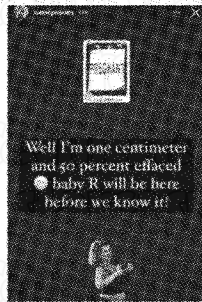

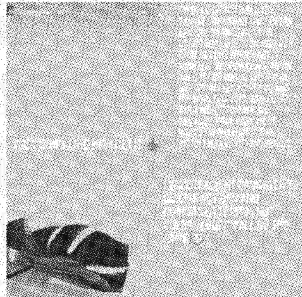

# 'Teen Mom 2's Kailyn Lowry Arrested For Allegedly Punching Ex Chris Lopez Over Son Lux's Haircut

Chris Lopez has accused Kailyn Lowry of 'attacking' and 'punching' him during an alleged dispute in Sept. 2020, according to court documents that HollywoodLife has obtained.

**UPDATE (10/29/20, 7:54 PM ET):** After Kailyn Lowry's arrest report surfaced, her rep provided the following statement to HollywoodLife: "Ms. Lowry has filed a petition for custody in the matter involving her children Lux and Creed. The judge in the Delaware Family Court has ordered the parties to refrain from discussing all domestic matters until after the hearing next year. Currently, Ms. Lowry has been awarded sole custody of the children despite the allegations pending in Family Court. Ms. Lowry does deny all of the allegations but cannot respond specifically at this time due to the orders of the judge."

**ORIGINAL:** Kailyn Lowry, 28, was arrested after she allegedly got physical with her ex-boyfriend, **Chris Lopez**, during a dispute about their three-year-old son **Lux's** haircut. The *Teen Mom 2* star was taken into police custody for "offensive touching" in Delaware on Sept. 26, according to court documents that HollywoodLife reviewed on Oct. 29. However, the dispute actually took place as the exes were exchanging custody of Lux at Chris's

home on Sept. 26, according to the documents.

Partially Redacted Police Report  
of September 4, 2020 Incident

Your Affiant OFF. GUILLEN can truly state that:

Your Affiant is a Sworn Police Officer with the New Castle County Police Department and has been employed by same since December of 2018. Your Affiant is currently assigned to the Uniformed Patrol Division Patrol Squad C.

1. On 09/25/2020 at approximately 1800 Your Affiant was dispatched to the area of [REDACTED] Wilmington, New Castle County, DE 19801 in reference to a reported domestic.
2. Should be noted that this domestic incident was reported on 09/04/2020 but the R.P. Christopher Lopez was never contacted. Christopher advised that he did not call back because he did not know the police was handling his complaint.
3. Your Affiant made contact with Christopher via telephone. Christopher advised that on 09/04/2020 at approximately 1649 hours he was struck by his ex-girlfriend, Kaitlyn Lowry [REDACTED] 1992 several times with a closed fist. Christopher did advise that he is a respondent to an active PFA where Kaitlyn is the petitioner, reference order 0112871. Christopher stated that Kaitlyn and his mother, Christine Lopez had arranged to have a child custody swap for Lux Lowry at his residence. Christopher stated that the once Lux was placed in Kaitlyn's vehicle she noticed that Christopher had gotten into a heated argument with Christopher. Christopher stated that Kaitlyn then returned to the residence and started attacking him but punching him several times on the head and upper torso because she did not want the child haircut. Christopher stated that he did not fight back and that Kaitlyn stated the same. Your Affiant contacted [REDACTED] via telephone [REDACTED] advised that Kaitlyn was to pick up Lux. [REDACTED] advised that Kaitlyn did not pick up Lux and that Kaitlyn did punch Lux on the back to prevent her from picking up Lux. [REDACTED] advised that Kaitlyn was upset about a matter on Lux which caused her to attack Christopher by punching him several times. [REDACTED] did state that she attempted to pull Kaitlyn off Christopher. [REDACTED] advised that Kaitlyn then left the scene.
5. Your Affiant then made contact with [REDACTED] via telephone. [REDACTED] did advise that she viewed Kaitlyn attack Christopher by punching him several times on the head. [REDACTED] advised that Christopher never struck Kaitlyn.
6. Your Affiant made contact with Kaitlyn via telephone. Kaitlyn advised that she was at the residence to pick up Lux. Kaitlyn stated that she was upset because Christopher cut Lux's hair. Kaitlyn stated that the dispute never became physical.
7. Based on the above information, Your Affiant prays a warrant be issued for the arrest of Kaitlyn Lowry.

**DECLARATION OF BRIANA SOTO p/k/a BRIANA DE JESUS**

I, Briana Soto p/k/a Briana De Jesus, declare:

1. I am over the age of 18 years and have never been convicted of a crime involving fraud or dishonesty. I have first-hand knowledge of the facts set forth herein, and if called as a witness, could and would testify competently thereto.
2. I am the Defendant in this matter.
3. I am a cast member on the television show *Teen Mom 2*.
4. I own and operate the Instagram account “@\_brianaDejesus.”
5. Plaintiff Kailyn Lowry was scheduled to appear on the June 8, 2021, episode of *Teen Mom 2*. She unexpectedly was removed from the episode.
6. On June 8, 2021, I posted a statement on the @\_brianaDejesus Instagram account in which I discussed Lowry’s removal from the *Teen Mom 2* episode. I deleted this post within 24 hours, but it was captured and reposted by the Instagram account “teenmom.tea,” which I do not own or operate, without my knowledge. A true and correct copy of the post, as re-posted by teenmom.tea, is attached to my Anti-SLAPP Motion for Summary Judgment Under Fla. Stat. § 768.295 (the “Anti-SLAPP Motion”) as **Exhibit 2**.

7. Also on June 8, 2021, I posted an Instagram Live broadcast in which I discussed this same subject. The broadcast, as captured and re-posted by teenmom.tea, can be found at: [https://www.instagram.com/tv/CP4gVlog8W-/?utm\\_medium=copy\\_link](https://www.instagram.com/tv/CP4gVlog8W-/?utm_medium=copy_link).

8. Prior to June 8, 2021, I was aware that Lowry had been arrested for allegedly physically assaulting her ex and father of two of her children, Christopher Lopez, in September 2020. I obtained this knowledge by reading media reporting on her arrest, as well as the investigative police report filed shortly before her arrest.

9. Specifically, I read an October 29, 2020 article from “Hollywood Life” titled “Teen mom 2’s Kaily Lowry Arrested For Allegedly Punching Ex Chris Lopez Over Son Lux’s Haircut.” A true and correct copy of this article is attached to my Anti-SLAPP Motion as **Exhibit 3**.

10. I also read the investigative police report included within the Hollywood Life article. A true and correct copy of the report, as included in the Hollywood Life article, is attached to my Anti-SLAPP Motion as **Exhibit 4**.

11. While I am aware the charges against Lowry were ultimately dropped, I am not aware of any statement from law enforcement or any prosecutor that Lowry was found innocent of physically assaulting Lopez.

12. Prior to June 8, 2021, I spoke to Lopez regarding Lowry’s alleged assault. He told me that Lowry did, in fact, physically attack her. He also told me that, as part of this attack, Lowry physically forced herself into the home of Lopez’s mother, where Lopez was at the time.

13. As an eyewitness to these events, and as a victim of them, I found Lopez’s statements to be credible and believable.

14. Having obtained this information, I felt confident that it was factually accurate to state that Lowry had allegedly attacked Lopez and had allegedly broken into his mother’s home as part of this attack. I made these statements as part of a criticism of reality television actors, like Lowry, who try to show audiences a cherry-picked, seemingly ideal picture of their daily life, even though audiences watch such programming because they want to see authenticity.

15. I did not harbor any doubt in my mind that my statements regarding Lowry at issue in this case were factually accurate or were expressions of my own subjective opinion.

16. I did not receive any form of pre-suit notice from Lowry or her attorneys before she filed her Complaint.

I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge.
